Nature of Work:

Provides system-wide leadership of the Library's Access Services department, which includes more than 60 FTE staff. Chairs the Access Services Leadership Team responsible for establishing priorities and procedures, recommending policies, and ensuring awareness of current trends, looking toward future directions for the Library. Serves on the Research, Teaching, and Engagement Senior Management Team and Directors Group and works with unit library directors to forward the Library's public services and to ensure that decisions regarding Access Services resonate with the Cornell community. Collaborates with several Library departments including Library IT and Library Technical Services. Supervises the Assistant Director of Access Services and the heads of the Library Annex, Interlibrary Services, Library Public Services, Olin & Uris Libraries Resource and Access Services, and Library Media Reserves. Represents Access Services on the FOLIO Governance Steering Committee. Works with the Interdisciplinary Team, the OKU Course Reserves group, and Selection Teams to ensure a coordinated approach to providing streaming film and media resources. Manages an annual allocation for streaming media.

Major Accomplishments:

- Assumed leadership of Olin & Uris Libraries Resource and Access Services in summer, 2023 and chaired a Unified Access Services Task Force the following fall which defined the responsibilities falling under the umbrella term of "access services" and created a plan to realize the goal of a unified access services department in support of the Library's "One Library" initiative. This ultimately resulted in my administrative portfolio more than tripling in size.
- Reorganized the Library Annex by creating a new leadership position, rewriting all other staff's job descriptions, and merging with the Library's Shipping & Receiving unit to add three new full-time roles. These changes have enabled us to provide growth and development opportunities for our entire team, prepare senior staff to step into temporary or permanent management roles, increase efficiency, and provide a better patron experience through more consistent fulfillment of patron requests.
- Oversaw testing, training, and implementation of functions relevant to access services during the Library's successful 2021 migration from the Voyager Integrated Library System to FOLIO, an open source library services platform that had not previously been used by a major research institution.

- Led an initiative to eliminate most library overdue fines and fees (all save recall fines and lost item replacement fees) as an initiative to support affordability and remove barriers to library use.
- Served as a member of a team that completed a multi-year project to migrate all of the Library's nearly 20 unit library websites to a new platform (WordPress) and ensure that they meet Web Content Accessibility Guidelines (WCAG) 2.0.
- Led a newly-created Access Services Response Team throughout the COVID-19 global pandemic. Highlights of this group's activities include creating a new contactless pickup service for physical materials and authoring the first three successful proposals to return library staff to campus in June, 2020.
- As a member of a five-person team, completed a project to redesign the main library website to better communicate changes to library services due to the initial COVID-19 response and subsequently to complement the phased reopening of the University.
- Appointed at the rank of Associate Librarian in 2019.

Nature of Work:

Provided leadership for the Terrapin Learning Commons (TLC) located in the main library for the University of Maryland campus in College Park, a public research institution serving a diverse community of more than 39,000 students and more than 10,000 faculty and staff. Oversaw operations of the TLC Tech Desk, a 24-hour service point offering equipment loan, group study room reservations, large and special-format printing, binding and laminating, and more. Oversaw operations of the John & Stella Graves MakerSpace, an instruction-oriented service point offering 3D printing, 3D scanning, AR/VR, and other developing technologies. As facilitator of the Equipment Loan Group, coordinated the activities of all the Libraries' equipment loan programs. Cultivated relationships with partners elsewhere on campus to provide additional student support services in the TLC. Managed a staff of 12.5 FTE, including two exempt staff, 2.5 FTE non-exempt staff, and eight FTE student assistants.

Major Accomplishments:

- Reorganized the TLC's staffing structure by revising job descriptions to designate everyone as the lead on some area of our operations; helping each staff member develop a plan for compiling and sharing monthly and yearly statistics reports; and instituting regular all-staff meetings to facilitate shared decision making.
- Introduced a popular new user-managed reservation system for group study rooms which dramatically reduced the amount of staff time devoted to room reservations and improved

the TLC user experience by streamlining the reservation process and eliminating the need for policy enforcement by staff.

- Oversaw the completion of a major project to standardize equipment loan program policies and procedures across the Libraries, ensuring a better and more consistent experience for our patrons.
- Created a strategic plan for the MakerSpace to focus on top priorities, address weaknesses and threats, and better communicate value to stakeholders, including through the adoption of a “lean start-up” approach to running it which gave us the flexibility to quickly pivot in response to feedback from our users.
- Developed a library instruction program based on the technologies in the MakerSpace and aligned with the Libraries’ information literacy goals which reached more than 400 instructors and students in the 2017-18 academic year.
- Promoted to the rank of Librarian III (equivalent to Associate Professor) with permanent status in 2018.

Managed the Library Media Services (LMS) department’s collection of more than 28,000 items in a wide range of formats. Worked with the Acquisitions Department on issues related to licensing audiovisual resources. Solicited and processed gifts and donations. Provided in-person and online instruction services with an emphasis on multimedia production. Marketed audiovisual collections and services to faculty and students with an emphasis on curricular use of materials. Served as primary selector for and librarian liaison to the Film Studies Program.

Major Accomplishments:

- Chaired a Media Commons Task Force whose final report provided LMS with a road map for reinventing itself as a “platform for learning” in line with the goals of the Libraries as a whole. Specific outcomes include development of a prototype multimedia production lab and a one-button studio for students working on presentations.
- Developed a comprehensive collection development policy statement for LMS to inform staff and library users about the collection and to establish standards for selection, gift acceptance, format duplication and retention, diversity, and other areas.
- Led a transition away from ad hoc library instruction centered around LMS’s collections and toward a more systematic program of instruction designed to promote media literacy.
- Led an initiative to make the LMS collection, which had been predominantly non-circulating, available for checkout to all faculty, staff, and students, and to make LMS materials available via regional and consortial ILL services.

Developed online learning objects and taught 10-20 library instruction sessions per semester as part of an extremely active information literacy program. Oversaw circulation functions utilizing the library's Polaris ILS and served as backup system administrator to the library's ILS Coordinator. Provided reference assistance to the College community. Participated in meetings of and jointly formulated policies and procedures for the Carroll Library Partnership consortium, which includes both academic and public libraries.

- Managed a successful library-wide shifting project that involved moving more than 100,000 books in less than four months.
- Helped write a successful application for a \$23,936 grant from the Knapp Foundation to develop a Flip camera lending program and purchase streaming video resources.
- Produced a number of short videos about the library, including one depicting "A Day in the Life of Hoover Library," a commercial for our interlibrary loan department, and a video tour of the library advertising our academic support services to students.
- Participated in the creation of McDaniel College's first institutional copyright policy.
